This course is specifically designed for all actively involved in animal experiments or related fields.

The course takes place in person

Dates

The course takes place twice a year (summer semester & winter semester).

Number of Participants

Summer semester: max. 35 participants

Winter semester: Number of participants is limited

course is part of their official curriculum.)

Seats will be allocated in order of receipt of registration.

Structure

The course consists of theory modules (& written test) and practical modules.

Theory modules:

- Take place in course week 1
- Written test in course week 2
- Required attendance of 80% and positive evaluation of the written test (60% correct answers)
- Test can be repeated twice

Practical modules:

- Take place in course week 3 and/or 4
- Participants are split in two groups
- A preferred group can be chosen on the registration form. Please note: There is no guarantee, the preferred group will be the fix group to participate in the end!

Prerequisites for participating the practical modules:

• Attendance in theory modules and positive evaluation of the written test
